The following shall be considered to be a part of the RFQ for LMS published by MSFDA.

1.	Whether cloud hosting charges for LMS to be borne by MSFDA itself or will be part of this quotation.	It is not necessary for the cloud hosting to be MEITY empanelled.			
		However, the proposed data centre shall provide at least 99.5% availability through the year.			
2.	Whether cost of streaming server will be borne by MSFDA or will be part of this quotation.	Streaming server is not to be considered. Video Content can be uploaded on public platforms such as YouTube.			
		Uploading and management of generated content (including audio / video / quizzes / documents / etc.) on the selected platform for 1 year shall be included in the scope of the bidder.			
3.	Whether subscription cost of Google meet or zoom meet required for synchronous session delivery will be borne by MSFDA or will be part of this quotation.	The subscription cost for any online video conferencing platforms shall be borne by MSFDA. However, the integration with the selected platform (Google Meet or Zoom) shall be the responsibility of the bidder.			
4.	Whether Mobile application development cost will be part of quotation.	Mobile application is removed from the scope of this bid. However, bidder shall ensure that the entire LMS is developed in a mobile responsive format.			
5.	Subscription cost of plagiarism checking application like Turnitin plugin will be part of this quotation or borne by MSFDA itself	The functionality for Plagiarism check is considered removed from the scope of this bid.			

6.	Concurrent Users	The initial setup shall be for a minimum of 500 concurrent users, which shall be scalable at a later date.		
7,	Student Management / Payment Gateway	Student Management and Payment Gateway are not in the scope of the current bid. However, two-way integration for the same shall be done with the current MSFDA website (www.msfda.ac.in)
