Registration Process

Step 7: Final Confirmation

- Upon successful payment, the registration for the selected program is completed.
- Participants receive confirmation and further program-related communication.

Important Note

- **User registration is a one-time, preliminary step only.**
- **Program enrolment, Centre approval, and fee payment are mandatory for each program.**
